3,5,6-trichloro-2-pyridinyloxyacetic acid: Dow AgroSciences Industrial Hygiene Guide is 2 mg/M3 as acid equivalent, Skin.

**EYE**: May cause eye irritation.

Triclopyr-butotyl, in animals, effects have been reported on the following organs: blood, kidney and liver.

**CANCER INFORMATION:** For a similar material: triclopyr: did not cause cancer in laboratory animals.

**TERATOLOGY (BIRTH DEFECTS):** Triclopyr-butotyl did not cause birth defects in laboratory animals. Has been toxic to the fetus in laboratory animals only at doses toxic to the mother.

**REPRODUCTIVE EFFECTS:** For a similar material triclopyr: in laboratory animal studies, effects on reproduction have been seen only at doses that produced significant toxicity to the parent animals.
